East Zone	- II - Jajpur, Kendrapara, Cuttack, Jagatsingpur
West Zone	-Sundargarh, Deogarh, Sambalpur, Jharsuguda, Bargarh, Nuapada, Bolangir, Sonepur
Central Zone	-Kandhamala, Boudha, Dhenkanal, Anugul, Kalahandi

Life / Fellow members of Central IAP attached to the State Branch are eligible to participate / Vote in the Election.

Terms & Eligibility Criteria

President Elect.

The term of the President shall be for one year.

The Life member contesting for the post of President Elect should have been a member of the Society for **10 complete years consecutively** as on 1st January 2020 to be eligible to contest for the ensuing election and should have served on the Executive Board or as State Office Bearer or both for a period of 2 complete years before contesting for the post of President Elect. The Chief editors of Indian Paediatrics and Indian Journal of Practical Paediatrics, OJP, Honorary Secretary, Joint Secretary, Treasurer and Organizing Secretary of Pedicon will not seek election for any the post of President elect till the completion of their present term in the office.

Secretary General

The term of the Secretary General shall be for two years.

A Life member contesting for the post of the Secretary General should have been a member of the Society for **7 complete years** consecutively as on or before 1st January 2020 to be eligible to contest for the ensuing election and should have served on the Executive Board for two complete years before contesting for the post of the Secretary General.

Treasurer

The term of the Treasurer shall be for two years.

A Life member contesting for the post of the Treasurer should have been a member of the Society for **5 complete years** consecutively as on or before 1st January 2020 to be eligible to contest for the ensuing election and should have served on the Executive Board for two complete years before contesting for the post of the Treasurer of the Society.

Executive Committee Members

The term of the elected Members to the Executive Committee shall be of a period of one year.

The Life member contesting for the post of Executive Board member should have been a member of the Society for **5 complete years consecutively** as on 1st January 2020 to be eligible to contest for the ensuing election. The term of the elected members to the Executive Board other than the Office Bearers shall be of a period of one year, and there shall be a ceiling of three years of continuous membership and there shall be a gap of one year for them to become eligible to contest again for Executive Board membership. The maximum period a member can be a member of Executive Board after excluding the post of Office Bearer shall be 6 years which shall include the period of Vice Presidentship.

All terms of office and Executive committee shall be from 1st January to December 31st.
