



Election Notification for Office Bearers of IAP, Odisha State Branch - 2023

Dear Members,

Election for the following office bearers for the year 2023 will be held as per the schedule mentioned below. Nomination is hereby invited from the Members.

President Elect:	1 Post	–	1 year.
Secretary:	1 Post	–	2 years.
Treasurer:	1 Post	–	2 years.
Executive Committee Members:	6 Posts (From Six different Zones) – 1 year.		

North Zone: Mayurbhanj, Balasore, Bhadrak, Kenonjhar.

South Zone: Malkangiri, Koraput, Nowarangpur, Rayagada, Gajapati, Ganjam.

East Zone-I: Khurda, Puri, Nayagarh.

East Zone-II: Jajpur, Kendrapara, Cuttack, Jagatsingpur.

West Zone: Sundargarh, Deogarh, Sambalpur, Jharsuguda, Bargarh, Nuapada,
Bolangir, Sonapur.

Central Zone: Kandhamala, Boudha, Dhenkanal, Anugul, Kalahandi.

The address of the Members will be considered as per the record of the C-IAP. Life / Fellow members of the Central IAP attached to the State Branch are eligible to participate / Vote in the Election.

Terms & Eligibility Criteria

President Elect.

The term of the President shall be for one year.

The Life member contesting for the post of President Elect should have been a member of the Society for **10 complete years consecutively** as on 1st January 2022 to be eligible to contest for the ensuing election and should have served on the Executive Board or as State Office Bearer or both for a period of 2 complete years before contesting for the post of President Elect. The Chief editors of Indian Paediatrics and Indian Journal of Practical Paediatrics, OJP, Honorary Secretary, Joint Secretary, Treasurer and Organizing Secretary of Pedicon will not seek election for the post of President elect till the completion of their present term in the office.

Secretary General:

The term of the Secretary General shall be for two years. A Life member contesting for the post of the Secretary General should have been a member of the Society for 7 complete years consecutively as on or before 1st January 2022 to be eligible to contest for the ensuing election and should have served on the Executive Board for two complete years before contesting for the post of the Secretary General.

Treasurer:

The term of the Treasurer shall be for two years. A Life member contesting for the post of the Treasurer should have been a member of the Society for 5 complete years consecutively as on or before 1st January 2022 to be eligible to contest for the ensuing election and should have served on the Executive Board for two complete years before contesting for the post of the Treasurer of the Society.

Executive Committee Members.

The term of the elected Members to the Executive Committee shall be of a period of one year.

The Life / Fellow member contesting for the post of Executive Board member should have been a member of the Society for **5 complete years consecutively** as on 1st January 2022 to be eligible to contest for the ensuing election. The term of the elected members to the Executive Board other than the Office Bearers shall be of a period of one year, and there shall be a ceiling of three years of continuous membership and there shall be a gap of one year for them to become eligible to contest again for Executive Board membership. The maximum period a member can be a member of the Executive Board after excluding the post of Office Bearer shall be 6 years which shall include the period of Vice Presidentship.

All terms of the office and Executive committee shall be from 1st January to 31st December
